<p>The Town of Newmarket Election Sign By-law 2017-74 establishes rules about election sign placement, sizes, installation and removal dates and other restrictions enforced by the Town of Newmarket. It is the responsibility of each candidate or his or her campaign staff to familiarize themselves with the rules for election signs in Newmarket. The Town will remove signs that are in violation of the Town of Newmarket Election Sign By-law 2017-74. Signs that have been removed will be available for pick up only after October 21, 2019.</p>

<p><input type="checkbox"/> I understand and acknowledge that information regarding the enforcement of The Town of Newmarket Election Sign By-law 2017-74 against me and my campaign, as it relates to the removal of election signs promoting myself as a candidate, may be publicly disclosed following the election.</p>			
<p><input type="checkbox"/> I acknowledge that the Town of Newmarket By-law 2017-66 Schedule F "2018 User Fees" sets a removal fee of \$25 per sign removed. If the Town of Newmarket removes an election sign promoting myself as a candidate due to a violation of Town of Newmarket Election Sign By-law 2017-74, this fee will form a storage lien against the sign removed in accordance with the Municipal Act, 2001 and the Repair and Storage Liens Act. I understand that any accumulated removal fees will be invoiced to me after October 24, 2019, and that if I fail to pay the invoice, the fees will be appended to my property taxes or sent to a collection agency as applicable. I understand that any signs removed by the Town will only be available for pick-up after payment of any applicable fees.</p>			
<p><input type="checkbox"/> I acknowledge that, if the Town of Newmarket removes an election sign promoting myself as a candidate due to a violation of Town of Newmarket Election Sign By-law 2017-74, the date of removal of the sign by the Town of Newmarket shall be deemed to be the date that storage of the sign commences in accordance with the Municipal Act, 2001 and the Repair and Storage Liens Act.</p>			
<p><input type="checkbox"/> In accordance with section 18 of the Town of Newmarket Election Sign By-law 2017-74, I understand that the candidate will hold harmless the Town and/or the Region (and the respective officers, Council members, partners, agents and employees of the Town and/or the Region) from and against (a) all actions, claims, demands, losses, costs, damages, suits or proceedings whatsoever which may be brought against or made upon the Town and the Region, and (b) against all losses, damages, liabilities, judgements, claims, suits, demands or expenses which the Town and/or the Region may sustain, suffer or be put to, resulting from or arising out of the issuance of the permit or the actions of the Candidate, Owner, Registered Third Party or Third Party.
